



## Foster Home Agreement

1. Foster parent must fill out a fostering application so that we have appropriate background information.
2. For Pets Sake provides foster homes with food for the foster pet.
3. For Pets Sake provides medical care for the foster pet through OUR rescue veterinarians (a list of available vet clinics will be provided to foster parent). Expenditures other than emergency care and treatment must be pre-approved by For Pets Sake.
4. Foster parent will bring the foster pet to and from adoption fairs and other activities, unless other arrangements have been pre-agreed upon. Please arrive early (prior to) start and end times.
5. Foster pet will not be left off leash in an unfenced area at any time.
6. Foster parent will keep the provided collar and tags on their foster pet at all times.
7. Foster pet will be kept indoors or in a fenced area on the grounds of the foster home. Additionally the foster pet will sleep indoors (garage is acceptable).
8. The foster parent will take proper care of the foster pet. Including providing pet with adequate food, water, shelter and exercise.
9. If medical problems arise foster parent will contact For Pets Sake immediately. For emergency treatment the foster parent will bring the foster pet to an authorized For Pets Sake veterinary clinic.
10. Foster puppies must not visit public areas other than our adoption center and our veterinary unless they are over than 4 months old and have had their 3 sets of vaccinations. (this is because at this age they are very susceptible to parvo and distemper so we try to limit their possible exposure). Puppies may not visit dog parks or other highly trafficked pedestrian/dog walkways (like Gulley Park, Murphy Park, or other public parks).
11. The foster parent will not be compensated for expenses incurred in the normal daily care of the animal.
12. For Pets Sake is not responsible for any events and/or damages that may occur as a result of fostering the pet. (i.e. things like soiled carpets, eaten shoes, and chewed-on furniture are not unusual occurrences). Please note that we do not knowingly place aggressive pets in foster care. If you suspect a pet may have aggressive tendencies, you must contact us IMMEDIATELY. We will not be responsible for injuries due to pet scratches, bites, etc.
13. The foster pet remains the property of For Pets Sake. The foster pet will be surrendered to For Pets Sake immediately upon request.
14. The foster pet can not be transferred to another party or location without approval from For Pets Sake.
15. The foster pet is to be adopted to its permanent home ONLY under approval of For Pets Sake, and our standard adoption policies will apply. Foster parent may refer candidate adopters directly to For Pets Sake.
16. For Pets Sake will NEVER release a pet from a foster home without an attending representative. Foster parents should NEVER turn a pet over to anyone without a For Pets Sake representative being present.
17. If the foster parent is interested in adopting their foster pet, our standard adoption policies apply, this includes completing an adoption contact as well as paying an adoption fee. This must be completed in a **timely manner**.

Please note: Since fostering is a short term situation the criteria for fostering is less stringent than for adoption. Qualifying as foster parent does not necessarily equate to qualification for adoption.
